

## Healthy Families ACUB Fact Sheet For FY 2014-2015

Healthy Families Florida is a nationally accredited home visiting program for expectant parents and parents of newborns experiencing stressful life situations. The program improves childhood outcomes and increases family self-sufficiency by empowering parents through education and community support. Parents voluntarily participate in Healthy Families so they can learn how to recognize and respond to their babies' changing developmental needs, use positive discipline techniques, cope with the day-to-day stress of parenting in healthy ways, and set and achieve short- and long-term goals.

During Fiscal year 2014-2015, Healthy Families ACUB provided 9,679 services to 537 families. HF ACUB employs 11 FTE Family Support Workers, 2 FTE Family Assessment Workers, 2 Supervisors, 1.25 FTE Mental Health Counselors, 1 FTE Program Assistant, and 1 FTE Program Manager.

Healthy Families ACUB operates under a \$1,202,805 budget. Healthy Families ACUB receives \$948,271 from the Ounce of Prevention Florida fund, the University of Florida provides 25% match amount (\$254,534), and HF ACUB \$51,702 from a United Way grant.

An assessment of Healthy Families ACUB Children for All Occurrences of Neglect for the report period of April 1, 2014-March 31, 2015 shows that 99% of all families served by Healthy Families ACUB were free from abuse and neglect during participation of the program and 100% of families severed from Healthy Families ACUB were free from abuse and neglect 12-24 months after completion of the program.

A review of Healthy Families ACUB's Outcome and Process measures of the four quarters of fiscal year 2014-2015 are included in the table shown below on the next page (pg 2). Percentages in Bold indicate met goals. All goals were met or exceeded during FY 2014-2015.

A comparison of the demographics of those families served against the demographics of the target population and the demographics of the home visitors is included on page 3 of this report.

Eighty-five (85) percent of participants who were low on one or more HFPI subscales will improve on at least one of the low subscales from baseline to six months.	N/D = 25/27 = <b>93%</b>
